This document may affect your legal rights and the rights of your child, including the right to sue or claim compensation following an accident

TO: Chinook River Sports Ltd., TransAlta Corporation, TA Alberta Hydro LP, Stoney Nakoda Developments Ltd., Stoney Nakoda Holdings Ltd., Stoney Nakoda Land Management Ltd., Mini Thni Casino Corp., Stoney Nakoda Nations, Stoney Indian Band, Stoney Tribal Administration, Bears paw First Nation, Chiniki First Nation, Goodstoney First Nation, and their respective owners, directors, officers, employees, agents, representatives, instructors, guides, contractors, subcontractors, sponsors, related companies, successors and assigns (all of whom are hereinafter collectively referred to as the “Releasees”).

This Notice to Parents and Guardians, Assumption and Acknowledgment of Risks Consent Form applies to River Activities as defined below.

DEFINITION

In this Notice to Parents and Guardians, Assumption and Acknowledgment of Risks Consent Form the term “River Activities” shall apply to all activities, events and services provided, arranged, organized, sponsored or authorized by the Releasees, including but not limited to: river rafting; white-water rafting; river boating; tours; wakeboarding; scenic nature floats; use of watercraft; use of boogieboards and wakeboards; swimming; cliff-jumping; use of safety equipment including personal floatation devices, helmets and wet suits; orientation and instruction sessions; all transportation or travel by foot or vehicle to and from the river or other drop-off locations; loading and unloading of vehicles and watercraft; consumption of food, water and other beverages; and all related activities.

ACKNOWLEDGMENT – RIVER ACTIVITIES SAFETY

I acknowledge that the Participant has been advised to wear both a helmet and a personal floatation device while participating in River Activities. Instruction as to the proper use of the helmet and the personal floatation device is available from the guides. I am aware that the River Activities and the use of other watercraft, may involve sudden, violent and unexpected movement of the craft, as well as physical exertion which may result in injury or aggravation of previous injuries, conditions, symptoms, or congenital defects. I have been advised to seek medical advice if I know or suspect that Participant’s physical condition may be incompatible with the River Activities. I acknowledge that the Participant will not be under the influence of drugs or alcohol while participating in River Activities. Communication on the river and in the backcountry is difficult, and rescue and medical treatment may not be available in the event of an accident. I acknowledge and agree that all expenses associated with non-scheduled or emergency evacuation, rescue or first aid will be my responsibility and will not be covered by the Releasees.

ASSUMPTION AND ACKNOWLEDGMENT OF RISKS

I am aware that participation in River Activities involves many risks, dangers and hazards including but not limited to: accidents which occur during transportation or travel to and from the river; slips, trips and falls; the overturning or upsetting of rafts; sudden, violent and unexpected movement of the raft; entrapment by trees, logs, rocks or equipment; drowning; hypothermia; exposure to very cold water; falling from the raft into long sections of continuous rapids; impact or collision with rocks, trees, logs, deadfall, other watercraft and equipment; encounters with domestic or wild animals; adverse weather conditions including high winds, lightning and thunderstorms; safety or other equipment failure; variation in the water conditions, surfaces and currents; negligent first aid; undercut and eroded riverbanks, obstacles and hazards; terrain that may not have been travelled on before and that is not regularly patrolled; becoming lost or separated from the guide; infectious disease contracted through viruses, bacteria, parasites, and fungi which may be transmitted through direct or indirect contact; negligence of other participants and **NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT MY MINOR CHILD (THE PARTICIPANT) FROM OR WARN OF THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN RIVER ACTIVITIES.**

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH PARTICIPATING IN THE RIVER ACTIVITIES AND I FREELY ACCEPT AND FULLY ACKNOWLEDGE ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

In signing this Notice to Parents and Guardians, Assumption and Acknowledgment of Risks Form, I am not relying on any oral or written representations or statements made by the Releasees regarding the safety of participating in River Activities, other than what is set forth in this Notice to Parents and Guardians, Assumption and Acknowledgment of Risks Consent Form.

ELECTRONIC SIGNING

I agree this Notice to Parents and Guardians, Assumption and Acknowledgment of Risks Consent Form may be signed electronically and this Notice to Parents and Guardians, Assumption and Acknowledgment of Risks Consent Form shall have the same legal validity and enforceability as a manually executed signature or use of a paper-based recordkeeping system to the fullest extent permitted by applicable law and I hereby waive any objection to the contrary.
